

**Publication of Proceedings in a special issue of  
*Nanotechnology Perceptions:*  
*A Review of Advanced Technologies and their Impacts***

Presenters at the SIPS Mamalis International Symposium (4–7 November 2018) have the opportunity for a written version of their presentation to be published in a special issue of the journal *Nanotechnology Perceptions: A Review of Advanced Technologies and their Impacts*, subject to the normal requirements for peer review.

**Guidelines for preparation**

Articles are typically between 3,000 and 5,000 words long but there is no formal minimum or maximum length. Illustrations are welcome. They may be embedded in the typescript for review purposes but separate files (preferably jpg or tif) should be sent with the final article. **Typescripts should be prepared in 12 point and double-spaced.**

The article should be submitted as early as convenient and no later than 15 December 2018, for publication the following March. An abstract should be provided. Final, revised articles taking account of referees' comments should be submitted by 15 February 2019.

**Style for references**

References should be made to all articles or books cited in the text, numbered in sequence as they first appear, with the numbers placed as superscripts or in square brackets in the text, following any punctuation marks. Footnotes (e.g., for remarks that would otherwise break the flow of the main text) should be numbered in a common sequence with the references. References and footnotes are printed at the bottom of the page on which reference to them is first made; in the typescript they may be listed on a separate sheet or sheets. The style is (see the examples given as footnotes):<sup>1,2,3</sup> Author; Article title; *Journal name* (in italic), using standard abbreviations where known (if in doubt, give the full title); non-English journal titles should never be translated (if transliterated, provide the original if there is doubt about the transliteration conventions); **Volume number** (in bold); Year of publication (in parentheses); First and last page numbers. Unpublished material should be referred to in the text as “unpublished data” or “personal communication”. Web references should give the URL and access date. Wikipedia references are not accepted.
