



### Biography of Migen Dibra

Migen Dibra was a Montreal Bar Award Recipient for Excellence in Civil Law (2003) and specialized in Civil and Common Law. She was a member of Quebec Bar and affiliated with numerous organizations such as Women in the Legal Profession Committee of the Montreal Bar, Consulting Committee of Businesspeople of Carrefour, Interuniversity Research Center on Labour Globalization. She was a Chair of FLOGEN SIPS Law Symposium from 2011 to 2023.

She was an excellent, all accomplished and successful lawyer equally in academic field, in court related research and guidance field as well as in litigation field. She was also a great speaker in international forums and conferences.

In academia she published numerous peer review articles in well-known law journals around the world. Her 2016 PhD thesis was a magnificent contribution of 761 pages to the right of employees during mergers and acquisitions. The title of the thesis in English is: "The Right of Participation of Canadian Employees During Restructuring of Enterprises: The British Legislative Framework as a Source of Inspiration for Canada and A Comparative Law Study: Quebec, Canadian Federal Legal Framework, European Union, United Kingdom". In court related research, one of her successes was the preparation of a Complete Guide of 129 pages for the judges of the Quebec Court of Appeal, the highest court in Quebec, Canada, entitled: "The Single Judge of the Court of Appeal of Quebec and a Guide of his/her functions" a guide used daily by Court of Appeal judges: <https://www.migenlaw.com/page4.html>
